**The 2025 Oita City Fixed-Amount Tax Reduction Supplemental Aid
(Shortfall Subsidy) Notification**

The Shortfall Subsidy is provided to individuals who received the 2024 Adjustment Subsidy*. To expedite payment, the subsidy was calculated using estimated 2024 income tax figures based on 2023 income data. As a result, some recipients may have received less than the amount to which they were entitled. This supplemental payment is provided to compensate for the difference.

*The Adjustment Subsidy is provided to individuals whose eligible tax reduction amount exceeds their estimated income and resident taxes for the 2024 fiscal year. The subsidy amount is the total of these differences, rounded up to the nearest 10,000 yen.

Based on your 2024 income and resident taxes, we are notifying you that you are eligible for this subsidy. The payment amount is shown below.

We will deposit the subsidy into the same bank account used for the 2023 and 2024 Low-Income Household Aid.
